Consolidated results for the half year ended September 30, 2021 does not include the figures of Leading Hotels Limited. Accordingly, any related party transactions pertaining to Leading Hotels Limited have not been included. Hence, the numbers for FY 2020-21 and as at March 31, 2021 reported above are not comparable to the numbers reported in the Annual report for the concerned period.
