('KFintech'), authorised agency engaged by the Company to provide the electronic voting facility till the time fixed for closing of the voting process i.e. on or before 05:00 P.M. (IST) on Thursday, August 22, 2024.

- **3.** The Members of the Company as on the "cut-off date" i.e. Friday, July 19, 2024, were entitled to vote on the proposed resolution to be passed through Postal Ballot by way of electronic voting means as set-out in the Postal Ballot Notice and their shareholding as on that date has been reckoned for the purpose of arriving at the results of the Postal Ballot.
- **4.** The E-voting period remained open from Wednesday, July 24, 2024 from 9:00 A.M (IST) and ended on Thursday, August 22, 2024 at 5:00 P.M (IST), on the designated website of KFintech i.e. (https://evoting.kfintech.com)
- 5. On Tuesday, July 23, 2024, the Company had completed the dispatch of Postal Ballot Notice, to its members whose name(s) appeared in the Register of Members/List of beneficial owners received from KFin Technologies Limited ("Registrar and Transfer Agent") as on the Cut-off date i.e., Friday, July 19, 2024 and whose e-mail IDs were registered with the Company and Depositories and Registrar and Transfer Agent.
